#### 6. Other Business

6.1 David Millar spoke to the concerns of the Provincial government creating new Crown Corporation called Lotteries and Gaming Saskatchewan (LGS) effective April 1, 2023. He would also like to see a representative from the rowing world be nominated to the Sasksport board. Nicole spoke to the new entity and advised that Sasksport and the LGS have signed a 5 year agreement to maintain the current level of funding and system of operating sport in Saskatchewan.
David also raised concerns with the loss of Canada Summer Games for rowing and sees this as a major failing for RCA. Andrew spoke to the loss of Games and how we are creating other standards by which to show Sasksport that our HP program and achievements of athletes continues. Andrew and with the support of the Provincial Advisory Committee (PAC) represented last year by Bryan Hillis, have been working with RCA Board to push the importance of getting back into games. The last messaging from RCA to PRA's was that Canada Games Council was changing how they measure and evaluate sports, and as soon as that is complete, RCA would be making a major push. Bryan highlighted that Andrew has been doing a great job representing Saskatchewan concerns at the national table. And that Canada Cup would be brought back as a standard for athletes to achieve success.
